It was **moved (Mark Cox), seconded (Bob Berryman), and carried** to accept minutes as presented from the 2021 Annual Congregational Meeting of 31 January 2021 and the Special Congregational Meeting of 11 July 2021 to elect the slate of church officers.

It was **moved (Paul Klunzinger), seconded (John Monahan), and carried** to receive the 2021 Annual Report.

It was **moved** (Mary Lu Yardley), seconded (Rick Theunissen), and carried to have David Stevens, treasurer, moderate the discussion regarding the pastor's terms of call. Andrew Miller and his family were excused.

It was **moved (Mary Lu Yardley), seconded (Allan Riggs), and carried** to accept the 2022 terms of call (page 2 of annual report).

Sabbatical Update: Andrew's sabbatical will move forward as planned (March 14, 2022 to June 12, 2022). Andrew asked for help in the church office in his absence with things like bringing in mail from the mailbox and other office-related tasks. A notebook of instructions will be kept in the Church office for needs for pastoral care. Andrew also announced that in his absence, Jeff Ellis has volunteered to be the contact person on issues related to the church building. He also announced that our Seminary Intern, Nathaniel Asperger, along with Mary Jo Cox will make sure all worship related tasks are covered. Andrew then outlined what he will do on his trip.

The 2022 budget was presented by Pastor Andrew. Approval was **moved (John Monahan)**, **seconded (Paul Klunzinger) and carried** to endorse the 2022 budget.

The Annual Meeting of the Congregation was adjourned and the Corporate Meeting called to order by David Stevens.

It was **moved (Amy Madsen), seconded (Marge Havens), and carried** for the corporation to accept minutes as presented from the 2021 Annual Congregational Meeting of 31 January 2021.

Isabella Child Development Center Annual Report January 2023

We currently have 33 children enrolled in preschool. Eighteen attend our morning 4-year-old program, and 15 attend the afternoon 3-year-old program. All families qualify based on our income guidelines.

Funding for the preschool comes from the state Great Start Readiness Program grant and ICDC The Thrift Shop. We also receive a great deal of support from First Presbyterian Church. So, thank you! Our families were very appreciative of the food bags given to them at Christmas.

Our curriculum is HighScope Preschool Curriculum. It supports children's development and learning in math, literacy, science, social studies, and the arts as well as social-emotional development. Children participate in a variety of activities in large and small groups and individually. We play outside daily.

Our children this year are particularly interested in music. We have instruments available for them daily. If you are in our hall during a school day, you are likely to hear them playing music. They also enjoy using Legos, blocks and art materials including recycled materials. A favorite activity of both groups is being able to play outside.

Current teaching staff includes Joyce Neyer, lead teacher/director and Kelli Artibee, associate teacher, and Krystal Martin, classroom aide.

Discipleship and Spiritual Formation Team 2022 Annual Report

Children and Worship – Our multi-age program for preschool through 5th grade continued throughout 2022 with a short break during the summer months. Children start in the sanctuary and then move down to the Children's Worship Center to continue their learning. Children and Worship includes a story presented by the Storyteller and then some individual worktime for reflection and extension on the stories being learned. On Communion Sunday (typically, the 1st Sunday of the month) children remain in the sanctuary with their families. Doug Lapp, Lane Demas, Wilson Gyasi, Marth Miller and Megan Goodwin lead the Children and Worship program with one serving as the Storyteller and another serving as a Greeter each week. Families continued to have the option to join worship via the FPC web page and through Facebook.

Confirmation - One youth, Connor Lowe, continued his confirmation work and joined the church in late 2022.

Adult Bible Study – The Adult Bible Study group continued their weekly meeting, on Sundays, in the parlor.

Workshops - Andrew Miller led two workshops for interested participants: The End-of-Life workshop involved about 25 attendees; and Being Presbyterian was a 6-week program with approximately 20 participants.

Family Connections - Devotional and activity calendars (Thanksgiving, Advent, and Lent) were made available to families and other church members several times throughout the year to celebrate the church seasons

Nursery - After a two-year hiatus due to the pandemic we were able to reopen the Nursery on Sunday mornings to provide a safe and caring space for our youngest members (typically infant -3 years) during worship. Mackenzie Guenin meets children in the Sanctuary and leads children (and parents) to the nursery where she provides care until parents return following worship.
